Regional and Local Government Structure in Norway

- □ <u>19 counties</u>
 - County Councils, elected
 - County Governors, representatives of the central government
 - State agencies
 - 430 Municipalities
 - Municipality Councils, elected



Division of Planning Tasks

 National Planning authority: Ministry of Environment Provides guidelines for planning at regional and local level

- White Papers
- National policy guidelines
- Resolve conflicts

Prepares county plans for the development of the county - Guidelines for the planning in the municipalities and sectorial planning

Prepares municipality masterplans and legally binding zoning plans

Planning authority: Municipal Council

The Planning Tasks of the Municipalities: Developing healthy, sustainable and climate proof cities and towns






My assumption: We have to mainstream adaptation to climate change as a "normal" spatial planning issue!

Climate Change

- Impacts and Adaptation Policy in Norway



Sudden events with large impacts:

• Heavy rainfalls, floods, springtides and land slides

Others more gradually and over time

Rising sea level and ecological changes

White paper on Climate Change Adaptation

- The proposition is now on public hearing
- Adaptation an issue primarly on the local level and subject to local decision
- Land use planning as the most important arena for adaptation policy
- However: One of the propositions is a new specified central regulation on climate change adaptation
- Suggests that **the County Governour** should have the main responsibility for the Adaptation policy at the regional level

What about the County Council's roles and tools? How can we strengthen the municipalities' capacity of implementing adaptation in the local spatial planning?







The County Councils tools in the planning system formal hierarchic steering through county plans

My Hypothesis: The County Councils have complementary roles and tools in the implementation of adaptation in the municipal planning

The County Councils role as a collaborator, partnership-builder and networker

	i	Little focus on deliberative work on dentifying a common understanding and "best solutions"	Strong focus on deliberative work on identifying a common understanding and "best solutions"
1	Strong steering	The municipalities may save time and gain a stronger position in the planning processes and can demand the actors to implement adaptation in the land use zoning plans. However this might lead to resistance and suboptimizing and heavy use of dispensations	The municipalities prepare sustainable land use zoning plans adapted to climate change
	Weak steering	The municipalities do not develop an understanding of the need for adaptation planning, and will not succeed in implementing adaptation in the land use zoning plans	The municipalities develop a common understanding about the need for adaptation planning, but because of the lack of sanctions and the weak steering from the County Council, adaptation is an issue in just a few of the spatial plans

A growing awareness of the need for climate change adaptation

The actors in the planning system ask for relevant knowledge

A sector-divided and uncoordinated state limits the possibilities of local adaptation


The municipalities ask for a coordinated adaptation policy!

However: The County plans should be prepared in cooperation with the municipalities in a communicative planning process!
