#### **Questions (Linkopping University) were divided in 4 groups:**

<u>Who are you?</u> (affiliation, organization, scopes of interests) <u>What is your opinion</u> on:

- local problems;
- impact of climate change at local level?

What are you doing because of climate change?

Selection of possible scenarios?

## Method:

real time guided quarry with demonstration of example of answers on the wall-screen;
examples of answers were specifically prepared from the point of view of 'an environmental engineer of small municipality';

- no big influences of these "artificial" opinions were found except some questions which demanded specific knowledge in climate changes

## What are the problems in general?

#### Nowadays problems:

- financial crisis and low number of working places
- low development of medium and small size economy
- Low level development of infrastructure
- Low standards of life
- Pollution of environment
- Absent of legal instrument of environmental management at local level
- Low qualification of workers

#### Problems after 20 years:

- reduction of population
- economical development lagging
- lowing of economical attraction of the Region
- deterioration of population health
- increasing of flooding and wetting of soils
- coastal erosion

← These are consequence of climate changes

- Low standards of life
- Pollution of environment







## Are climate changes an important issues?

- 75% (22 persons) climate changes influence their activity
- 19% (6 persons) no influence from climate changes
- 6% (2 persons) no comments

Been force to think deeply the most of respondents were agree, that climate change issues are important and should be considered in their activities

## Who is already dealing with climate change problems?

80% – not at all
20% - partly as we are working with environmental problems, which are in general are linked with climate



# Which sector (or issues) and how will be influenced by climate changes?














### How important are climate changes?
